

## End User License Agreement

PLEASE READ THE TERMS AND CONDITIONS OF THIS LICENSE AGREEMENT (THE "AGREEMENT") CAREFULLY BEFORE INSTALLING AND/OR USING THE AQUARIUS SPECTRUM LTD APPLICATION ("SOFTWARE"). THE SOFTWARE IS COPYRIGHTED AND LICENSED (NOT SOLD). BY DOWNLOADING AND INSTALLING THE SOFTWARE YOU ARE ACCEPTING AND AGREEING TO BE BOUND BY ALL THE TERMS OF THIS AGREEMENT. THIS AGREEMENT IS BETWEEN YOU AND AQUARIUS SPECTRUM LTD ("AQUARIUS") ONLY. IF YOU DO NOT AGREE TO THIS AGREEMENT, DO NOT DOWNLOAD AND/OR INSTALL THE SOFTWARE, AND IF YOU HAVE ALREADY INSTALLED IT PLEASE REMOVE IT FROM YOUR DEVICE AND DO NOT USE IT IN ANY MANNER WHATSOEVER.

1. **Payment and Consideration.** You may download the Software to your device for no consideration or payment. The Services (as defined below) may be used and accessed solely with Aquarius's proprietary mobile sensor which may be purchased separately, and connected to your mobile device. For more information on Aquarius's proprietary mobile sensor and means of purchase, please refer to Aquarius's website. The Services enabled by the Software as well as Aquarius's mobile sensor are subject to payment. In order to purchase the relevant Services, receive access to the Software and determine the scope of the Services provided, you need to register at Aquarius's website, choose the applicable Services and scope, choose the method of payment and complete the payment for such Services. Before you can use the Service, Aquarius shall confirm payment has been completed through its website. The Software will enable you to use the Services only to the extent and in the scope of Services you have purchased or have been authorized. For purchase of Services, scope of Services available, and the status of the Services ordered by you, please visit Aquarius's website or the Settings section in the application. Aquarius reserves the right to change its Service offerings from time to time, to amend the scope of Services offered and to offer different Services in different scopes to various customers and end users. In any event that payment for Services is delinquent, for any reason whatsoever, then, without derogating from any other remedy under applicable law or this Agreement, Aquarius shall be entitled to immediately deny access and/or use of the Software and the Services.
2. **License Grant.** Subject to the terms herein, Aquarius hereby grants you a limited, non-exclusive, non-transferable, non sub-licensable right to install and receive access to the Software on mobile device that you own or control, and use it in order to identify water leaks in water pipes, and to observe, review, analyze and generate reports based on the data collected (the foregoing actions enabled by means of the Software shall be herein after referred to as "**Service**"). You shall be solely responsible to ensure that the Software is securely installed and used. The term "Software" shall include all revisions, improvements, new releases and/or updates and related documentation all to the extent provided by Aquarius under this Agreement.
3. **Restrictions.** THE SOFTWARE IS LICENSED TO YOU; IT IS NOT SOLD. Other than the rights explicitly granted in this Agreement, you shall have no other rights, express or implied, in the Software. Without limiting the generality of the foregoing, you agree and undertake not to: (i) sell, lease, sublicense or distribute the Software, or any part thereof, or otherwise transfer the Software; (ii) reverse engineer, decompile, disassemble, or otherwise reduce to human-perceivable form the Software's source code and or any third party software provided by Aquarius; (iii) modify, revise, enhance, or alter the Software; (iv) copy or allow copies of the Software to be made except for backup or archival purposes and only throughout the term hereof; (v) place the Software onto a server accessible for use by any third party; (vi) use the Software on any mobile device that you do not own or control, and you may not distribute or make the Software available over a network where it could be used by multiple devices at the same time except as required for its proper use and operation; (vii) represent that you possess any proprietary interest in the Software; (viii) use the Software in any illegal manner or for unlawful purposes.
4. **Content.**
  - 4.1. The Service enables you to add, create or use certain content which you provide or which is generated through your use of the Software, including, without limitation your personal information, your usage information, location, comments, posts, photos etc. (each, a "**User Submission**"). Aquarius does not guarantee that User Submission in all formats will be made available through the Service and does not guarantee that formats which are currently available will continue to be made available in the future.
  - 4.2. By submitting any User Submission on or through the Service, you (a) understand that whether or not such User Submission is made available through the Software, Aquarius does not guarantee, and is not under any obligation of, confidentiality with respect to any User Submission, and agree that any User Submission provided in connection with the Service is provided on a non-proprietary and non-confidential basis; (b)

represent and warrant that you own or have all necessary rights and permissions to use and authorize Aquarius to use all intellectual property rights in and to any User Submission for the purpose of providing the Service; (c) represent and warrant that your User Submission does not infringe or violate the rights of any third party, including, without limitation, any right of privacy; (d) grant Aquarius a worldwide, non-exclusive, perpetual, irrevocable, royalty-free, fully-paid, sub-licensable and transferable license to use, edit, modify, reproduce, prepare derivative works based upon and otherwise exploit, the User Submission in connection with the provision of the Service, the improvement of the Service and its operation, and/or Aquarius's business.

6. **Indemnity.** UNDER NO CIRCUMSTANCES WHATSOEVER WILL AQUARIUS OR THE OPERATING SYSTEMS' PROVIDER (E.G. GOOGLE) BE LIABLE IN ANY WAY FOR ANY CONTENT (WHETHER PROVIDED BY AQUARIUS OR UPLOADED BY YOU), INCLUDING, WITHOUT LIMITATION, FOR ANY ERRORS OR OMISSIONS IN ANY CONTENT, OR FOR ANY INFRINGEMENT OF THIRD PARTY'S RIGHT, LOSS OR DAMAGE OF ANY KIND INCURRED AS A RESULT OF THE USE OF THE CONTENT AND/OR THE SOFTWARE. Any disclosure or unauthorized use thereof will cause irreparable harm and loss to Aquarius. All right, title and interest in and to the Software, any derivatives thereof and modifications thereto, including associated intellectual property rights, evidenced by or embodied in and/or attached/connected/related to the Software, are and will remain with Aquarius. This Agreement does not convey to you an interest in or to the Software, but only a limited right of use in accordance with the terms herein. Nothing in this Agreement constitutes a waiver of Aquarius's intellectual property rights under any law.
8. **Consent to Use of Data.** By using the Software, you acknowledge that you have reviewed and agreed to Aquarius's Privacy Policy available on its website. YOU AGREE THAT AQUARIUS MAY COLLECT AND USE PERSONAL DATA THAT YOU SUBMIT AS WELL AS TECHNICAL DATA, AND RELATED INFORMATION, including but not limited to technical information about your device, system and application software, and peripherals, that is gathered periodically to facilitate the provision of software updates, product support and other services to you (if any) related to the Software. Aquarius may also collect data related or generated from your use of the Service for statistic analysis and usage patterns analysis. 10. **Limited Warranty.**

THE MANNER BY WHICH ANY SPECIFIC LEAK SHOULD BE HANDLED AND/OR REPAIRED IS DEPENDENT ON NUMEROUS FACTORS WHICH ARE OUTSIDE OF THE SCOPE OF THE SOFTWARE AND SERVICES AND WHICH SHOULD BE SEPARATELY ADDRESSED AND CONSIDERED BY YOU AT YOUR SOLE RESPONSIBILITY. UNDER NO CIRCUMSTANCES WILL AQUARIUS, ITS SHAREHOLDERS OR ANY OTHER PARTY ON ITS BEHALF BE LIABLE FOR ANY DAMAGE, LOSS OR EXPENSE (INCLUDING PHYSICAL INJURIES) WHICH MAY BE CAUSED TO YOU OR TO ANY ONE ACTING ON YOUR BEHALF OR TO ANY THIRD PARTY ARISING FROM OR IN CONNECTION WITH YOUR USE OF OR RELIANCE ON THE SOFTWARE OR SERVICES, INCLUDING WITHOUT LIMITATION, ANY DAMAGE, EXPENSE OR LOSS CAUSED AS A RESULT OF WATER LEAKS OR BURSTS, DAMAGES TO PIPING SYSTEMS AND/OR THE LIKE.

13. **Term and Termination.** This Agreement is valid as of the date you purchased the license. Without prejudice to any other rights, this Agreement and your right to use this Software automatically terminates if you fail to comply with any provision of this Agreement. Aquarius may terminate this Agreement at any time with or without prior notice. You may terminate this license at any time by stopping your use thereof and un-installing the Software. Upon termination of this Agreement for any reason the license granted to you in this Agreement shall expire and you shall cease using the Software and remove it from your devices. All amounts paid are non-refundable in any case, except as required by applicable law.

Sections 3, 4, 5, 6, 7, 8, 10, 11, 12 and 14 shall survive any termination of this Agreement for any reason whatsoever.

14. **General.** This Agreement along with the Privacy Policy, and the Product Terms and Conditions (which accompany the appliance attached to the mobile device which you had purchased from Aquarius) constitutes the entire agreement between the parties and may not be modified except by a written agreement signed by Aquarius. If a court of competent jurisdiction finds any provision of this Agreement to be unenforceable, that provision shall be enforced to the maximum extent permissible so as to affect the intent of the parties, and the remainder of the Agreement shall continue in full force and effect. You may not assign this Agreement without Aquarius's prior written approval. Aquarius shall be entitled to assign this Agreement at its discretion. No waiver of any breach shall constitute a waiver of any prior, concurrent or subsequent breach of the same or any other provision, and no waiver shall be effective unless made in writing and signed by an authorized representative of the waiving party. This Agreement shall be governed by and construed in accordance with the laws of Israel and only the competent courts in Tel Aviv, Israel shall have jurisdiction over any dispute arising from this Agreement. The application of the United Nations Convention of Contracts for the International Sale of Goods is expressly excluded.
